Accidental Death and Dismemberment Coverage

For a nominal charge, accidental death and dismemberment coverage will be added to the General Liability policy for insureds in most states. This coverage provides a lump sum payment to an insured's employees when they are injured on the job. Since the payment amount is spelled out in the policy by type of injury, the adjustment of the claim is done almost immediately and many payments are made within two weeks. The coverage will be added for insureds in the following states: AL, AK, AZ, CA, CO, DE, GA, ID, IL, IN, IA, KY, ME, MA, MI, MN, MS, MO, MT, NE, NV, NH, NM, OH, OR, RI, SC, UT, VT, WI and WY.
